I will also email a copy of updated Financial Guarantee Letter to sponsoredstudents@unsw.edu.au. A new Confirmation of Enrolment will only be provided upon receipt of approval from the Sponsor.

Please note that Australian privacy legislation does not permit the University to release a student's personal information to a third party without the express written permission of the student.
