It is a condition of your sponsorship and acceptance of offer to study at UNSW Sydney that you read, understand and agree to the following:

- Unpaid invoices:** Any invoices unpaid by the sponsor may result in the termination or suspension of the student's enrolment (affecting student visa status, graduation, library and computer access etc).
I acknowledge that I will be personally liable for any tuition fees or other such charges unpaid by my sponsor.
- Change of Program:** The student is responsible for obtaining their sponsor's approval prior to requesting change of program. If program change is approved by the sponsor, the student may proceed with the program change request. The student must provide sponsoredstudents@unsw.edu.au with an updated Financial Guarantee and new completed ISSA Form.
- Extension of Approved Program and Visa:** The student is responsible for obtaining their sponsor's approval for any extension to the duration of the approved program of study, as will be advised by the International Student Compliance Team. If approval for extension is granted by the sponsor, the student will obtain an updated Financial Guarantee and share this with: international.student@unsw.edu.au, sponsor.ar@unsw.edu.au and sponsoredstudents@unsw.edu.au. A new Confirmation of Enrolment (COE) will only be issued upon receipt of an updated Financial Guarantee from the sponsor.
- Suspension and/or exclusion from Program:** The student will notify their sponsor in the case of academic suspension or exclusion immediately, or as early as possible.

I agree that UNSW may provide my sponsor with access to information relating to my academic studies (eg. academic transcripts, progress reports) as well as information related to past and current cases available to UNSW staff through CRM databases. Please note that Australian privacy legislation does not permit the University to release a student's personal information to a third party without the express written permission of the student.
