

GOVERNANCE APPROVAL TIMELINES FOR 2027 OFFERINGS (AS AT 22 SEPTEMBER 2025)

This timeline is provided to guide staff involved in the development and approval of proposals for new, discontinued, and substantially revised offerings for 2027. Refer to the <u>ECLIPS Support Hub</u> for advice about approval levels for different types of revisions, as not all changes need approval by university level committees.

The table below includes the **key** activity and governance deadlines to ensure a smooth launch of new and revised programs. A full calendar of university level committee dates is included below the table.

Sufficient time should also be allowed for:

- Review and approval of the Authority to Proceed (ATP) and preparation of business case documents (applies to new programs and specialisations) and commencing discussions around CSP allocations (where relevant). Allow 2-4 weeks for ATP approval by DVCAQ.
- 2. Submission dates for Faculty Committees that allow time for review and processing proposals (2 weeks prior to circulation of papers is recommended).
- 3. Faculty committee dates that align with university committee dates to ensure efficient pathway to Academic Board.
- 4. Addressing feedback and actions requested by committees (where relevant).
- 5. Ready for Market approval by DVC Academic Quality (new programs) and CSP allocation discussions (where relevant), as well as configuration in systems following Academic Board approval.
- 6. CRICOS registration application for programs planned for international students studying in Australia on student visas. Following final approval of the program, contact the Office of the DVC Academic Quality, to arrange a CRICOS application to TEQSA. An outcome can take at least one month but doesn't affect opening applications to domestic students.

For proposals to suspend or move a program into teachout (disestablishment):

- Decisions to suspend applications or move a program into teachout must take into account the 18
 month lead time for direct applications, students who have received an offer (including deferments) and
 international students who have received conditional package offers and may already be in Australia to
 complete English studies with UNSW College prior to commencing their university program. These
 students and the university are placed in a difficult position when a program is cancelled in the 12
 months prior to an intake.
- 2. DVC Academic Quality approval via ECLIPS is required. Assessment of impacts on existing students and applicants at different stages of the application process is critical before actioning or communicating such decisions.
- 3. The Office of the DVC Academic Quality must be notified by June each year of intended program and specialisation closures for the following academic year in order to meet Department of Education requirements. In some instances, further discussions with the Department will be required before a program or specialisation can be closed.

23 June 2026	ACADEMIC BOARD Section 5.3 of the Academic Offerings Approval Procedure: All new and revised academic offerings must be approved by 30 June in the year prior to the first intake to ensure that all necessary arrangements (e.g. Handbook publication, CRICOS registration, marketing and agent notification, student load planning, student enrolment planning, and resource development) are in place before commencement, and to meet key administrative deadlines for curriculum planning, publishing, myPlan configuration and enrolment. The exception is new research programs or coursework programs which are fully online and associated new offerings. These must be approved at least six months prior to the first intake. Academic Programs Advisory Group can recommend a shorter cut-off date in exceptional circumstances.
Mid-August 2026*	Term of offering deadline for courses to be offered in all teaching terms in 2027. Students enrol for all 2027 terms from October 2026. Course delivery details for the full year should be up to date in ECLIPS as this information is needed for term planning and creation of course enrolment (CRS) classes. Summer Term and Term 1 2027 Term Planning deadline (timetabling requirements and clash free course combinations).

Late August 2026*	Release of 2027 Online Handbook.
Early September 2026*	Open Day. Absolute last opportunity to promote new undergraduate programs that have missed previous recruitment collateral and events.
