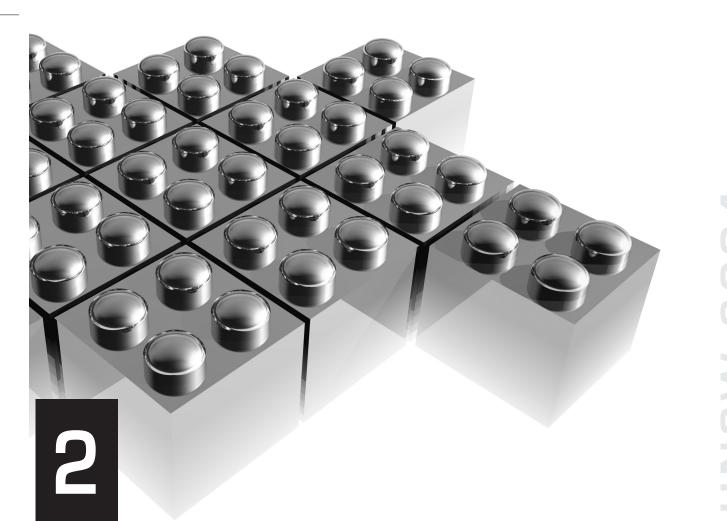

#### FINANCE

## **Financial Report**

The Financial Report for the year ended 31 December 2004 has been prepared in accordance with Section 41B of the Public Finance and Audit Act 1983 and the *Guidelines for the Preparation of Annual Financial Reports for the 2004 Reporting Period by Australian Higher Education Institutions* issued by the Department of Education Science and Training (DEST). The New South Wales Auditor General has furnished an audit opinion on the Report in terms of Section 41C(1B) and 1(C) of that Act. Both the Report and the opinion are shown on pages 13–14 of this Annual Report.

The consolidated financial report has been prepared for the University and its controlled entities on an accrual basis in accordance with the policies disclosed in the Report.

#### Consolidated results for 2004

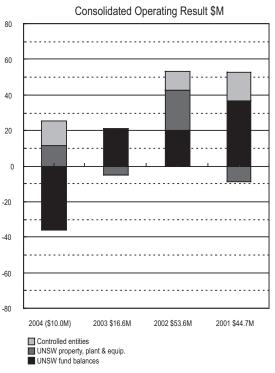
The consolidated operating result for the year ended 31 December 2004 was a loss of \$10.0M (\$16.6M surplus in 2003). Significant and prior period items contributing to the operating loss of \$10.0M in 2004 were:

- During 2004, the Commonwealth changed the timing of payments of operating grants under the Higher Education Funding Act 1988 (HEFA) to universities. The impact on the University's and consolidated 2004 results was a \$21.3M reduction in operating revenues and operating result;
- The writedown from \$17.4M to nil of the fair value of University owned land that is used by affiliated residential colleges and Commonwealth activities and is subject to long term leases. The impact on the University's and consolidated 2004 results was a \$6.0M increase in operating expenses, \$17.4M reduction in land valuation and \$11.4M reduction in the asset revaluation reserve;
- A \$5.6M increase in revenue representing HECS student contributions received during the period 1996 to 2002 which were correctly recognised as income in adv ance, but not transferreed to revenue in subsequent years;

- · A \$11.9M increase in expenses and provisions following an actuarial valuation of thr University's liability for long service leave; and
- Settlement of a dispute arising from UNSW's participation in the Cooperative Research Centre for Eye Research and Technology (CRCERT). The impact on the 2004 results were a \$6.1M debt write off and \$2.2M reduction in revenue with a corresponding \$2.2M increase in non-current liabilities. UNSW has a continuing entitlement to a percentage of royalties that are paid to CRCERT. Because UNSW is not able to quantify the value of its share of the royalty payments, this has been disclosed as a contingent aset.

Table 1 shows the break up of the consolidated operating results for the last four years in terms of movements in University cash and non-cash assets, and assets of controlled entities.

During the year Reserves increased by \$20.3M due to:

- \$11.8M net increase in property, plant and equipment arising from revaluations;
- \$11.4M decrease due to the write down in the fair value of University owned land that is used by affiliated residential colleges and Commonwealth activities and is subject to long term leases;
- \$20.2M increase in the market value of long term investments, ie unrealised gains; and
- \$0.3M in net transfers to retained surplus.

By the end of 2004, UNSW's liability for New South Wales State emerging cost superannuation schemes had decreased to \$351.7M, a \$0.9M decrease on the previous year. Movements in the liability over the last five years have been:

Under the accounting treatment that is required to be adopted, the increment in the liability in 2004 equally decreases University and Consolidated revenues and expenses by \$0.9M (increase of \$43.4M in 2003). On the Statement of Financial Position, the University's liability for New South Wales State emerging cost superannuation schemes is included in the Provision for Staff Superannuation and is offset by recognising the Government as a debtor in Receivables. In order to avoid misleading comparisons between years, throughout the analysis and commentary that follows, *Deferred Government Superannuation Contributions* and *Deferred Employee Benefits for State Superannuation* have been excluded from revenue and expenses.

After excluding *Deferred Government Superannuation Contributions*, revenue increased by \$27.9M, or 3.3 per cent, over the year from \$838.5M to \$866.4M, due to the following movements:

Due largely to the changes in payment arrangements, as a percentage of total revenue Commonwealth Government financial assistance decreased from 38.8 per cent in 2003 to 37.3 per cent in 2004. When taken together with HECS, Commonwealth loan programs and New South Wales governments the percentage is 49.2 per cent in 2004, compared to 51.2 per cent in 2003.

After excluding *Deferred Employee Benefits for State Superannuation*, expenses rose by \$54.5M over the previous year, or 6.6 per cent. Movements were:

Net cash from operating activities, investment activities and Government increased by \$69.8M, compared with a \$30.3M increase in the previous year. Payments for Property, Plant and Equipment in 2004 were \$83.0M, compared to \$56.8M in 2003.

Assets have increased by \$2.3M and liabilities have decreased by \$13.9M, with the result that by the end of 2004 net assets had increased by \$11.6M or 1.0 per cent. Changes in assets and liabilities included:

#### Assets

Overall cash and investments increased by \$16.2M, which included \$20.2M in unrealised gains in long term investments;

The value of land and buildings, net of depreciation, increased by \$19.4M, which included a net increase of \$8.5M due to revaluations and a \$17.4M decrease due to the write down of land impaired by long term leases. The value of plant and equipment, net of depreciation, decreased by \$8.1M;

Deferred Government Superannuation Contributions decreased by \$22.4M, due primarily to UNSW receiving a payment from the Commonwealth for the unfunded superannuation liabilities of staff at the University College, ADFA. Other receivables increased by \$2.3M and other assets (including inventories) decreased by \$9.71M;

#### Liabilities:

Provisions for long service leave, annual leave, workers compensation and Professorial Superannuation increased by \$13.2M. Provisions for Deferred Employee Benefits for State Superannuation decreased by \$0.9M;

Accrued expenses and sundry creditors decreased by \$0.6M and \$2.3M, respectively; and,

Income in advance decreased by \$29.7M and other liabilities increased by \$6.4M.

### University (only) results for 2004

The University's 2004 Budget was approved by the Council of the University on 15 December 2003. The 2005 Budget was approved by Council on 22 November 2004. Tables 3, 4 and 5 compare the actual results for the University (excluding controlled entities) with the estimated statement of financial performance, statement of financial position and statement of cash flows as shown in UNSW Budgets.

The operating result for 2004 was \$36.6M less than budget.

Significant and prior period unbudgeted items that contributed to the University's under performance compared to budget of which most have been commented upon earlier in the report, were:

- A \$21.3M decrease in Commonwealth financial assistance due to changes in the payment arrangements implemented by the Commonwealth Government in 2004;
- A \$5.6M increase in revenue for HECS student contributions received during the period 1996 to 2002, which is shown as a prior period error;
- Increases of \$11.8M and \$4.1M for provisions for long service leave and employers superannuation, respectively;
- · Write downs of \$6.0M for land, \$3.3M for buildings and \$4.6M for investments in unlisted companies; and
- A \$6.1M debt write off and \$2.2M reduction in other revenue frollowing settlement of a dispute arising from UNSW's participation in a Cooperative Research Centre.

At the end of 2004 net assets were \$13.6M less than budget.

A significant item that contributed to total assets being \$7.9M less than budget was the \$17.4m write down in the fair value of University owned land that is used by affiliated residential colleges and commonwealth activities and is subject to long term leases. At \$626.4 actual total liabilities exceeded the budget by \$22.4M. Just over 25.0 per cent of this increase, \$5.7M, is due to increase in provisions for deferred employee entitlements, of which \$3.2M is for provisions for Deferred Employee Benefits for State Superannuation

The net cash from operating and investing was \$45.9M above budget. Payments for property, plant and equipment in 2004 were \$65.2M less than the budget estimate.

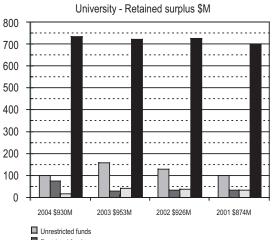

### Retained surplus of the University

The University's retained surplus (ie excluding controlled entities) decreased by \$23.6M over the year from \$953.4M to \$929.8M, see Table 6. While property, plant and equipment (after excluding revaluations) increased by \$11.9M, fund balances (cash assets) decreased by \$35.5M. The decrease in fund balances was comprised of: a \$23.2M decrease in Commonwealth grants in advance or unexpended, due to changes in the payment arrangements implemented by the Commonwealth Government in 2004; a \$44.0M increase in restricted funds; and a \$56.3M decrease in unrestricted funds.

### **Investment Management and Performance**

The University's investment activities are regulated by the University of New South Wales Act 1989.

During 2004 the University's investments were divided between the following three investment Pools:

- Pool L, a long-term investment fund with an investment horizon of more than two years managed by seven external fund managers;
- Pool S, the University's short-term working capital with an investment horizon of less than two years managed internally by UNSW's Investment Services; and
- Pool P, investments in special projects and property (generally residential) managed internally by UNSW's Investment Services.

In accordance with the Annual Reports (Statutory Bodies) regulations the performance of Pools L and S are measured in Table 7 against Treasury Corporation Facilities. It is not appropriate for Pool P's performance to be measured in this way as it is a project fund and its investment criteria and horizon differ markedly from any of the Treasury Corporation facilities.

In contrast to the previous year, in 2004 bond returns were substantially better than cash returns, as there was a modest fall in bond yields. The Australian share market was very strong, with the accumulation index for the largest 300 stocks rising by 27.9 per cent during the year, the largest rise in a calendar year since 1993. International shares also did well in contrast to 2003, given that markets were strong and the Australian dollar appreciated only mildly against the US dollar. In this environment UNSW's investments again performed well, both in an absolute and relative sense.

Pool L returned 16.48 per cent after all fees which was 1.33 per cent better than the composite benchmark Treasury Corporation facility. The main contributions to this high return and level of out–performance came from UNSW's international equities, which were 50 per cent hedged against currency movements, as well as the value added by the University's external managers.

Pool S returned 6.69 per cent after all fees, which was 1.13 per cent better than the cash facility offered by Treasury Corporation. Table 8 shows realised and unrealised investment income for 2004 and 2003.

#### Notes

- 1. No interest has been charged for any late payments.
- 2. Actual per cent of accounts paid on time is based on the number of transactions processed. However, when expressed in monetary terms, the per cent of accounts paid on time differs because of a large dramatic effect of a small number of transactions that may have been delayed for various reasons.
- 3. The reimbursements to employees and students have payment terms of an immediate nature. Claims are submitted to Accounts Payable after they have been incurred. The invoice date used is the date the claim is prepared rather than the receipt date of the claim which does not accurately represent payment performance.
- 4. Where payment terms are exceeded by UNSW, generally this is due to either goods not received, payment delayed due to goods not received in a satisfactory condition or invoices not received from suppliers in a timely manner.

#### **Consultants**

Under Schedule 1 of the Annual Reports (Statutory Bodies) regulation UNSW's Annual Report is not required to contain information on consultants. For this voluntary disclosure to be consistent with similar information provided by other Statutory Bodies, UNSW has applied the definition of a consultant as outlined in the *Guidelines for the engagement and use of consultants* issued by the Public Employment Office.

# Significant items raised by the New South Wales Auditor-General in Management Letter

The following information summarises major issues raised by the New South Wales Auditor–General in the Management Letter for the year ended 31 December 2003 and the actions undertaken by University management.

Ar	ea of Identified Deficiency	Action
1.	Bank reconciliation	The University has reviewed and substantially redesigned the bank reconciliation methodology. Responsibility for the bank reconciliation has been transferred to a newly formed reconciliation and compliance team.
2.	Bank reconciliation process	Errors and reconciling items are identified in the period they occur, investigated and cleared on a timely basis. Bank reconciliations are reviewed and signed off by the senior management in Finance, including the CFO.
3.	Cash receipts/debtors batch processing	Processing of batches is actioned one batch at a time, rather than all batches being done as part of an overnight process. System changes have introduced additional validation during data entry. The Accounts Receivable supervisor reviews the posting error correction screen daily, and notifies appropriate staff if an error is detected. New receipting software has been implemented.
4.	Preparation of financial report	Some year end processes were undertaken earlier than in previous years. The review by senior management in Finance, internal and external audit was undertaken prior to submission of the 2004 Financial Report to the Minister and AONSW on 11 February 2004.
5.	Year-end journal processing	All year end journals for \$500,000 or greater were reviewed by senior management in Finance. Staff who have access to online journal processing have been reminded of the necessity to fully complete the journal input forms. Sample reviews are carried out to assess completeness.
6.	Accounting policies and procedures	Accounting policies have or are being reviewed and updated.
7.	Grant refunds	The University has amended its processes and support systems for the refunding of research grant monies.
8.	Risk management	By the end of 2004 the University has substantially completed a program of work to develop a risk management policy, a risk management plan, a risk register, and a business continuity plan, using a combination of inhouse and external consultancy resources. The University is committed to implementing and maintaining the processes that will be established by these plans to identify, assess, manage, monitor and report on risk exposures on a systemic basis.

#### Qualified Audit Opinion

In my opinion, except for the effects of such adjustments, if any, as might have been required at 31 December 2003 had the limitation discussed in the qualification paragraph not existed, the financial report of the University of New South Wales:

- 1) presents fairly the University of New South Wales' and the consolidated entity's financial position as at 31 December 2004; and financial performance and cash flows for the year ended on that date, in accordance with applicable Accounting Standards and other mandatory professional reporting requirements in Australia, and
- 2) complies with:
  - i) section 41B of the *Public Finance and Audit Act 1983* (the Act), and
  - the Financial Statement Guidelines for Australian Higher Education Providers for the 2004 Reporting Period, issued by the Australian Government Department of Education, Science and Training.

My opinion should be read in conjunction with the rest of this report.

#### Qualification

As disclosed in Note 10, the University recognised \$8.353 million in 2003 as revenue and cash to adjust a prior period error. At that time the University was unable to identify the cause or nature of the error and accordingly, I was unable to obtain all the information and explanations I required to form an opinion on that transaction. During 2004 the University identified the cause and nature of \$3.663 million of the error, and confirmed this was appropriately treated by the 2003 transaction. It has, however, been unable to confirm the cause and nature of the balance of the error of \$4.690 million.

#### The Council's Role

The financial report is the responsibility of the Council. It consists of the statements of financial position, the statements of financial performance, the statements of cash flows and the accompanying notes for the University of New South Wales and the consolidated entity. The consolidated entity comprises the University of New South Wales and the entities it controlled at the year's end, or during the financial year.

#### The Auditor's Role and the Audit Scope

As required by the Act, I carried out an independent audit to enable me to express an opinion on the financial report. My audit provides *reasonable assurance* to Members of the New South Wales Parliament that the financial report is free of *material* misstatement.

My audit accorded with Australian Auditing and Assurance Standards and statutory requirements, and I:

- evaluated the accounting policies and significant accounting estimates used by the Council in preparing the financial report, and
- examined a sample of the evidence that supports the amounts and other disclosures in the financial report.

An audit does *not* guarantee that every amount and disclosure in the financial report is error free. The terms 'reasonable assurance' and 'material' recognise that an audit does not examine all evidence and transactions. However, the audit procedures used should identify errors or omissions significant enough to adversely affect decisions made by users of the financial report or indicate that members of the Council had failed in their reporting obligations.

My opinion does not provide assurance:

- about the future viability of the University of New South Wales or its controlled entities,
- that they have carried out their activities effectively, efficiently and economically, or
- about the effectiveness of their internal controls.

#### Audit Independence

The Audit Office complies with all applicable independence requirements of Australian professional ethical pronouncements. The Act further promotes independence by:

- providing that only Parliament, and not the executive government, can remove an Auditor-General, and
- mandating the Auditor-General as auditor of public sector agencies but precluding the provision of non-audit services, thus ensuring the Auditor-General and the Audit Office are not compromised in their role by the possibility of losing clients or income.

# NOTES TO AND FORMING PART OF THE FINANCIAL REPORT FOR THE YEAR ENDED 31 DECEMBER 2004

### 1 Significant accounting policies

The significant policies that have been adopted in the preparation of this financial report are:

#### (a) Basis of Preparation

The financial report is a general purpose financial report prepared in accordance with the requirements of the *Public Finance and Audit Act 1983* and regulations, and the *Financial Statement Guidelines for Australian Higher Education Providers for the 2004 Reporting Period*, issued by the Department of Education Science and Training (DEST) and is drawn up in accordance with applicable Accounting Standards and other authoritative pronouncements of the Australian Accounting Standards Board.

The financial report is prepared on an accrual basis and the policies adopted, except where otherwise stated, are consistent with those of the previous year. The measurement base applied is historical cost accounting except to the extent that investments are valued at market value and certain non-current assets have been revalued as disclosed elsewhere in the notes. Market/existing use values of assets (except investments) and liabilities, where they differ significantly from the historical cost basis, are shown separately in the notes.

Variations to comparative figures may occur due to rounding. Comparative information where necessary, is reclassified to achieve consistency in disclosure with current financial year amounts and other disclosures. Where additional information is provided due to changes in disclosure requirements, comparative figures may not be available.

## (b) Financial effects of changes to Commonwealth payment arrangements for 2005 grant year. Background

Payment to universities in respect of programs under the *Higher Education Funding Act 1988* (HEFA), are made on the second and last Thursdays of each month. In the recent past, the first payment in respect of a grant year (equalling 8 per cent of the total recurrent funding for that year) had been made at the end of December of the previous year. In accordance with accounting standards, this funding was recorded as revenue in the year of receipt.

Funding for most programs under HEFA ends on 31 December 2004 while most new programs under the Higher Education Support Act 2003 (HESA) commence on 1 January 2005. Continuing the current practice of making the first payment in December 2004 for the 2005 grant year would mean that Commonwealth payments would be made in respect of programs that are yet to commence and that these payments are treated by the majority of universities as revenue for 2004. This has considerable accountability implications for the Australian Government Department of Education, Science and Training (DEST) in administering and accounting for the program payments.

Higher Education Providers (HEPs), even those within the same state, do not treat the early payment uniformly and the payment is treated in at least three different ways – as revenue when it is received, as an advance (a liability) and part as revenue and the other as liability. Such varied treatment creates a lack of transparency and distorts both the Commonwealth funding and the HEPs' financial year results.

DEST has announced changes to payment arrangements whereby all recurrent payments in respect of a grant year will be made in that year. For the 2005 grant year, the first payment will be made in January 2005 instead of December 2004.

The changes to payment arrangements means that from the 2005 reporting period, the financial statements of all HEPs will reflect the Commonwealth financial assistance in respect of a grant year.

#### Financial Effects for 2004

Changes to payment arrangements mean that those HEPs that reported the whole or part of the 8% first payment in respect of the 2004 grant year as revenue in 2003 will have the effect of understating the Commonwealth funding for the 2004 grant year in their 2004 Statement of Financial Performance.

To identify the impact of the changed arrangements, grants provided for 2004 activities but recognised as 2003 revenue should be adjusted by incorporating the amount received in December 2003 as revenue for the 2004 reporting period. The effect of this is shown below:

The Commonwealth will use the restated figures in all DEST publications, including the Finance 2004 publication, to ensure consistent treatment across all HEPs.

#### (c) Principles of Consolidation

The consolidated financial statements incorporate the assets and liabilities of all entities controlled by the University of New South Wales ("parent entity") as at 31 December 2004 and the results of all controlled entities for the year then ended. UNSW and its controlled entities together are referred to in this financial report as the consolidated entity. The effects of all transactions between entities in the consolidated entity are eliminated in full. Outside equity interests in the results and equity of controlled entities are shown separately in the consolidated Statement of Financial Performance and Statement of Financial Position respectively.

Where control of an entity is obtained during a financial year, its results are included in the consolidated Statement of Financial Performance from the date on which control commences. Where control of an entity ceases during a financial year, its results are included for that part of the year during which control existed, unless an exemption from consolidating part year results has been issued by the New South Wales Treasurer.

The accounting policies adopted in preparing the financial report are consistently applied by entities in the consolidated entity except as otherwise indicated.

Separate financial reports are also prepared by the University's controlled entities and are audited by the Auditor General of New South Wales.

#### (d) Income Tax

The University is exempt from income tax under Commonwealth income taxation legislation. Within the consolidated entity however, there are entities that are not exempt from this legislation. For these entities, the consolidated entity adopts the liability method of tax—effect accounting whereby the income tax expense for the period is based on the profit from ordinary activities adjusted for any permanent differences between taxable and accounting income.

Timing differences which arise due to different accounting periods in which items of revenue and expense are included in the determination of accounting profit and taxable income are recognised as either a provision for deferred income tax, or as a future income tax benefit, at the rate of income tax applicable to the period in which the benefit will be received or the liability will become payable.

Future income tax benefits, including tax losses, are not recognised unless realisation of the benefit is virtually certain.

The recognition of income tax benefits is based on the assumption that adverse changes will not occur in income taxation legislation and the consolidated entity will derive sufficient future assessable income so the benefits may be realised and comply with the conditions of deductibility imposed by the law.

#### (e) Revenue Recognition

#### **Operating Revenue**

Financial assistance provided by the Government under the Higher Education Funding Act is recognised in the year in which it is received (see 1(a) for further information).

Grant revenue not received under the Higher Education Funding Act is recognised in the year to which the Grant applies.

The Postgraduate Education Loans Scheme (PELS) provides an interest–free loan facility, with income contingent repayment arrangements similar to the Higher Education Contribution Scheme (HECS), for eligible students enrolled in fee paying postgraduate non–research courses.

PELS enables eligible students to obtain a loan from the Commonwealth Government to pay all or part of their tuition fees incurred from 1 January 2002 onwards. *Section 98G of the Act* allows the Commonwealth to make advance payments to institutions. Under the PELS payment arrangements, the Commonwealth makes two payments per year to universities following the receipt of a 'claim for payment', which itemises the universities' expected costs for PELS for each of the two specified periods.

#### Student fees

Student fees are recognised as debtors following the census date for each session. The full value of student fees payable are recognised as revenue, with any fee waivers or discounts being recognised as an expense within the Statement of Financial Performance.

#### Sale of goods and services

Sales revenue comprises revenue earned (net of returns, discounts and allowances) from the supply of products to entities outside the consolidated entity. Sales revenue is recognised when the control and title of goods passes to the customer.

#### Fees and charges for services

Revenue from services rendered is recognised in the period in which the service is provided, having regard to the stage of completion of the service.

#### Investment income

Interest income is recognised as it accrues. Dividend income is recognised as it is received.

#### Proceeds of sale of property, plant and equipment

The gross proceeds of asset sales not originally purchased for the intention of resale are included as revenue at the date an unconditional contract of sale is signed.

#### Other revenue

Represents miscellaneous income and other grant income not derived from core business.

#### (f) Trusts and Other Liabilities

Revenue and expenses in respect of Trusts, Cooperative Research Centres and investments held on behalf of associated entities are recognised under Other Liabilities. Funds held and invested on behalf of controlled entities are recognised as Other Liabilities in the Statement of Financial Position of the parent entity (UNSW) and are eliminated on consolidation.

#### (g) Foreign currency

Transactions denominated in a foreign currency are converted at the exchange rate at the date of the transaction. Foreign currency receivables and payables at balance date are translated at exchange rates at balance date. Exchange gains and losses, whether realised or unrealised, are brought to account in determining the operating result from ordinary activities as they arise.

Exchange gains and losses and costs arising on forward foreign exchange contracts entered into as hedges of specific commitments are deferred and included in the determination of the amounts at which the transactions are brought to account. All exchange gains and losses and costs relating to other hedge transactions are brought to account in the Statement of Financial Performance in the same period as the exchange differences on the items covered by the hedge transactions.

#### (h) Receivables

#### Sundry and student debtors

Sundry and student debtors are carried at amounts receivable, with sundry debtors settled within 30 days and student debtors settled in accordance with the credit terms published in the University of New South Wales calendar. The collectability of debts is assessed at balance date and specific provision is made for any doubtful accounts.

#### Provision for doubtful debts

The provision for doubtful debts is assessed based on aged sundry debtors and past experience of the enrolment status of private and sponsored students.

#### (i) Financial assets

Market values of fixed interest financial assets are calculated by the application of the relevant valuation formulae. Unit Trusts are valued by reference to Redemption Unit Prices. Ordinary shares in Listed Companies are valued by reference to closing sale prices.

Financial assets other than shares in unlisted companies that form part of the University financial assets portfolio are revalued every year at 31 December. All realised and unrealised income on short–term financial assets is recognised in the Statement of Financial Performance. Unrealised income on long–term investments is brought to account through the Financial Assets Revaluation Reserve.

Investments in unlisted companies are carried at the lower of cost or recoverable amount. These amounts are assessed every year at balance date.

Long-term investments are investments that have a maturity date in excess of one year or where the University intends to hold the investments for more than one year.

For the purposes of the Statement of Cash Flows, cash and cash equivalents means cash on hand and highly liquid investments maturing in less than 90 days, which are readily convertible to cash on hand and are subject to an insignificant risk of changes in value.

#### **Biosignal Pty Ltd**

During 2004 Biosignal Pty Limited was taken over by Biosignal Limited (formerly known as CTI Communications Limited). To finalise the takeover, all of the shareholders of Biosignal Pty Limited agreed to sell 100 per cent of their holdings in Biosignal Pty Limited to Biosignal Limited in exchange for various securities in Biosignal Limited. In exchange for their holdings the University and Unisearch received the following:

The value of ordinary shares and options has been brought to account at cost, based on the value at which these were issued under a Rights Issue by Biosignal Limited.

The ordinary shares and options are recorded at cost, \$4.013M Consolidated and \$1.527M University, in the Financial Report at 31 December 2004, as detailed in the offer prospectus at the time of the takeover by Biosignal Limited. The performance shares have been recognised at nil value because their value is dependent on the future performance of the company.

As at 31 December 2004, the ordinary shares and options are held in escrow for sale for up to two years. A portion of the ordinary shares will be released from escrow in April 2005 as part of a voluntary agreement entered into at the time of acquisition. The remainder, escrowed under ASX Listing Rules, will be released from escrow in April 2006. All escrow positions will be released immediately should a takeover offer be made for the company.

#### (j) Inventories

Inventories are carried at the lower of cost and net realisable value.

#### (k) Property, plant and equipment

#### **Acquisitions**

Assets with a useful life of more than 12 months and a cost of acquisition in excess of \$5,000 are capitalised at cost. Cost is the purchase price plus costs associated with installation where assets are purchased, or all planning and construction costs associated

with constructed assets. Costs incurred on plant and equipment which do not meet the criteria for capitalisation and are not a component of a complex asset, are expensed as incurred.

The cost of constructed buildings, plant and equipment includes the cost of materials, direct labour and a proportion of overheads and other incidentals directly attributable to the asset's construction.

#### Complex assets

Major items of plant and equipment comprising a number of components that have different useful lives are accounted for as separate assets. The components may be replaced during the useful life of the complex asset.

#### Subsequent additional costs

Costs incurred on property, plant and equipment subsequent to initial acquisition are capitalised when it is probable that future economic benefits in excess of the originally assessed performance of the asset will flow to the consolidated entity in future years. Where these costs represent separate components of a complex asset they are accounted for as separate assets and are separately depreciated over their useful lives.

#### Carrying value

Land, Infrastructure assets, Buildings, Works of Art and Rare Books are recognised at fair value. Where available, fair value is determined having regard to the highest and best use of the asset on the basis of current market selling prices for the same or similar assets. Where the market selling price is not available, the asset's fair value is measured at the replacement cost of the asset's remaining future economic benefits.

Buildings, Infrastructure assets, Residential Property held for teaching, research and other University purposes are valued at written down replacement cost.

Land (zoned for educational special purposes), and Other Residential Property and Student Accommodation assets are valued at current market value.

All other assets that have relatively short useful lives, including the following, are measured at cost that equates to fair value:

- Computer Equipment,
- · Computer Software,
- Motor Vehicles,
- Office Equipment,
- Other Equipment, and
- · Library Holdings (other than rare books).

Assets acquired since valuation are valued at cost.

#### Revaluations

Building, Land and Infrastructure assets, Works of Art, and the rare book component of Library Holdings are revalued every five years, or more frequently if considered necessary, to ensure that the carrying amount of each asset in the class does not differ materially from its fair value at balance date.

Student Accommodation and Residential Property and their associated infrastructure assets are valued as at 31 December each year.

#### **Valuations**

**1997 valuations**: In accordance with the University's asset policy, Egan National Valuers (NSW) Pty Ltd valued the animal breeding facility at Little Bay, as at 9 April 1997, on the basis that it is being held for limited continued use and the service potential would not be replaced if the University were deprived of it.

**2000 valuations**: McWilliams and Associates Pty Ltd valued Works of Art as at December 2000. Land assets and approximately one-third of the building and associated infrastructure assets were valued as at 31 December 2000 by the New South Wales State Valuation Office.

**2003 valuations**: Egan National Valuers (NSW) valued a portion of Student Accommodation and Residential Property as at 31 December 2003. The remainder of this asset class and Building and Land assets were valued by HP Consultants Pty Ltd as at 31 December 2003. Neil Boness, Rare Book and Special Collections Librarian, University of Sydney undertook valuation of the University's rare and valuable book collection in 2003.

2004 valuations: Egan National Valuers (NSW) valued a portion of Student Accommodation and Residential Property as at

31 December 2004. The remainder of this asset class and Building and Land assets were valued by HP Consultants Pty Ltd as at 31 December 2004.

#### Disposal of assets

The gain or loss on disposal of assets is calculated as the difference between the carrying amount of the asset at the time of disposal and the net proceeds on disposal and is included in the results in the year of disposal.

#### **Depreciation**

Property, Plant and Equipment, including Buildings but excluding Freehold Land, Student Accommodation and Residential Property, Works of Art and Rare Books are depreciated / amortised, on a straight line basis, over the estimated useful life of the asset. Additions are depreciated from the date of acquisition.

Depreciation expense is based on the capital cost of items and is calculated, on the straight line basis, at the following rates per annum:

#### (I) Non-financial assets

Patents are amortised over their economic life, usually 20 years.

#### (m) Operating leases

The University leases certain property and equipment by way of operating leases. Payments for these leases, whereby the lessors effectively retain substantially all the risks and benefits of ownership of the leased items, are charged to the Statement of Financial Performance in the periods in which they are incurred.

#### (n) Employee entitlements

#### Annual Leave

Provision is made for the University's liability for annual leave arising from services rendered by employees to balance date. Annual leave benefits are measured at the amounts 'expected to be paid' when the liability is settled, plus related on—costs. The full liability for annual leave is recognised as a current liability within the Statement of Financial Position.

#### Long Service Leave

The University commissioned KPMG Actuaries, Sydney, to perform an actuarial valuation of its liability for long service leave as at 31 December 2004.

#### Staff Superannuation

The University contributes to the following superannuation schemes:

- (i) Schemes managed by the State Authorities Superannuation Trustee Corporation (STC)
  - State Superannuation Scheme (SSS);
  - State Authorities Superannuation Scheme (SASS); and
  - State Authorities Non-Contributory Superannuation Scheme (SANCS).

The STC Actuary completed the assessment of the Gross Superannuation Liabilities for the schemes for the year ended 31 December 2004.

During 2004, UNSW reached an agreement with the Commonwealth Government regarding unfunded superannuation

liabilities in respect of staff at the University College ADFA. Settlement was received in December 2004 upon which the obligation of meeting the current and future liabilities for these staff transferred from the Commonwealth Government to UNSW.

The 2004 assessment of SASS, SANCS and SSS is based on the full requirements of AAS25 – Financial Reporting by Superannuation Plans. AAS25 requires that a "market determined risk adjusted discount rate" be applied as the valuation interest rate in the calculation of the value of accrued benefits.

In order to satisfy the AAS25 requirements, the assumptions of the New Sourth Wales Government Actuary were as follows:

#### (iii) UniSuper

The University also contributes to UniSuper (formerly Superannuation Scheme for Australian Universities (SSAU) for academic staff appointed since 1 March 1988 and all other staff from 1 July 1991. UniSuper is a fully funded scheme.

On 30 June 2004, Towers Perrin completed the latest actuarial assessment as at 31 December 2004. The University is not liable for any deficiency in assets of the scheme.

The following figures only relate to members who are in the Defined Benefit Plan as at 30 June 2004.

#### (iv) Other Superannuation Schemes

The University and its controlled entities also contribute to the following superannuation schemes, which are fully funded.

- Commonwealth Superannuation Scheme
- University of New South Wales Special Purposes Superannuation Scheme (a Scheme restricted to short–term staff employed on special purpose funds).

#### Workers' Compensation

The University has been granted a license under Division 5 of Part 7 of the Workers' Compensation Act, 1987. In accordance with the license the University has the following bank guarantees:

- \$5,070,000 with ANZ Banking Group in favour of WorkCover New South Wales; and,
- \$768,000 with ANZ Banking Group in favour of ACT WorkCover.

Workers' compensation matters are managed through two funds, one to record the University's workers' compensation activities in New South Wales (known as the NSW Fund) and one to record the University's workers' compensation activities in the Australian Capital Territory (known as the ACT Fund).

As a self-insurer, the University sets a notional annual premium, which is charged on in-service salaries. Costs of workers' compensation claims, claims administration expenses and actuarially assessed increases/decreases in the provision for outstanding claims liability are met from the notional premium. The University contributes to the WorkCover authorities for its general fund, dust and diseases fund, insurers guarantee fund, and disaster insurance premiums.

It is also a requirement of the licence that the University maintain a provision for each fund in respect of outstanding claims liability as at 31 December each year.

#### (o) Financial Instruments

Financial Instruments are defined as any contract that gives rise to both a financial asset of the University and a financial liability or equity instrument of another entity. For the University these include cash, receivables, accrued income, sundry advances, payments in advance, loans to members of staff, investment interest receivable, investments, sundry creditors, prepaid income, Commonwealth grants received in advance, employee entitlements and other liabilities.

In accordance with AAS33 Presentation and Disclosure of Financial Instruments, information is disclosed in respect of the interest rate risk and credit risk of financial instruments (note 33). All such amounts are carried in the accounts at net fair value unless otherwise stated. The specific accounting policy for each class of financial instrument is stated hereunder.

Classes of instruments recorded at cost comprise:

- Cash
- Term deposits
- Receivables
- Accrued income
- Sundry advances
- Payments in advance
- Interest receivable on financial assets
- · Commonwealth financial assistance paid in advance
- · Sundry creditors
- Prepaid income
- Other liabilities

Classes of instruments recorded at market value comprise:

- Government and semi-government securities
- · Listed shares
- Other securities
- · Liquids (Bank Bills, Floating Rate Notes, NCDs, etc)

#### Cash

Cash is cash at bank.

### Sundry debtors, sundry creditors and payments in advance

- Sundry debtors, carried at amount due, are generally settled within 30 days from date of invoice. A provision is raised for any
  doubtful debts based on a review of all outstanding amounts at balance date. Bad debts are written off in the period in which
  they are identified.
- Sundry creditors, including accruals not yet billed, are recognised when the University becomes obliged to make future payments as a result of a purchase of goods or services. Sundry creditors are generally settled within 30 days of date of receipt of invoice.

Payments in advance are recognised when payments are made for goods and services to be delivered after the balance date.

#### Accrued and prepaid income

 At balance date, the University recognised over-expended and under-expended balances for all contractual agreements with external organisations (other than for Commonwealth Government grants) as accrued and prepaid income respectively.

#### Financial assets

· The University has brought its financial assets to account at market value, except shares in unlisted companies as detailed in note 20.

#### (p) Cooperative research

The University is involved in cooperative research through a number of ventures. Contributions in cash and in-kind are expensed and included in the Statement of Financial Performance. The University's percentage of interest (share of contribution) is not included in the Statement of Financial Position.

#### (q) Goods and Services Tax

Revenues, expenses, property, plant, and equipment are recognised net of the amount of Goods and Services Tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of the asset or the expense.

Receivables and payables are stated with GST included.

The net GST recoverable from, or payable to, the ATO is included as a current asset or liability in the Statement of Financial Position.

Cash flows are included in the Statement of Cash Flows on a gross basis. The GST components of cash flows arising from investing and financing activities which are recoverable from, or payable to, the ATO are classified as operating cash flows.

#### (r) Responsible persons and executives

For the University, responsible persons are members of the University Council.

For controlled entities, responsible persons are the directors of those entities.

For the University, executives are the Vice–Chancellor and any person in a senior line position reporting to the Vice–Chancellor whose remuneration for the year ended 31 December 2004 was \$100,000 or more.

For controlled entities, executives are the Chief Executive Officers of those entities and any person in a senior line position reporting to the Chief Executive Officer whose remuneration for the year ended 31 December 2004 was \$100,000 or more.

#### (s) Medical malpractice insurance

Under a letter of agreement between the New South Wales Department of Health and the Universities of Newcastle, New South Wales and Sydney, clinical academic staff of the Universities are indemnified whilst working in the public health system. The letter of agreement requires universities to meet the first \$255,000 for each and every claim up to a maximum of \$1.02M in one year, and is effective until 30 June 2005.

The University does not have commercial insurance coverage for medical malpractice for its students.

#### (t) International Financial Reporting Standards (IFRS)

The Australian Accounting Standards Board (AASB) is adopting IFRS for application to reporting periods beginning on or after 1 January 2005. The AASB has issued Australian equivalents to IFRS, and the Urgent Issues Group has issued interpretations corresponding to IASB interpretations originated by the International Financial Reporting Interpretations Committee or the former Standing Interpretations Committee. The adoption of Australian equivalents to IFRS will be first reflected in the consolidated entity's financial statements for the year ending 31 December 2005.

Entities complying with Australian equivalents to IFRS for the first time will be required to restate their comparative financial statements to amounts reflecting the application of IFRS to that comparative period. Most adjustments required on transition to IFRS will be made, retrospectively, against opening retained surplus as at 1 January 2004.

In collaboration with two other New South Wales universities, UNSW selected an accounting firm to assist it with assessing the

impacts of IFRS and implementation of IFRS. UNSW's implementation consisted of six phases, resulting in a prioritised assessment of the impacts of IFRS on UNSW and its controlled entities' accounting policies and financial statement disclosures, and also a project action plan identifying the tasks required to fully prepare UNSW for IFRS.

UNSW formed a project team, which provided progress reports to UNSW's Audit Committee on 29 September 2004 and 15 November 2004. The final report produced by the accounting firm engaged by UNSW was received on 24 December 2004 and UNSW is still analysing certain choices IFRS provides to determine the most appropriate accounting policy for the consolidated entity.

Major changes identified to date that will be required to the consolidated entity's existing accounting policies include the following (references to new AASB standards below are to the Australian equivalents to IFRS issued in July 2004):

#### (i) First Time Adoption of IFRS Property, Plant and Equipment

AASB116 Property, Plant and Equipment

AASB1 First Time Adoption of IFRS

IFRS allows for each class of property, plant and equipment to be carried at either:

- cost less accumulated depreciation (on transition, UNSW can elect to measure an item of property, plant and equipment at fair value and use that fair value as its deemed cost from that date); or
- revalued amount less any subsequent accumulated depreciation.

As a not-for-profit entity, UNSW must maintain its revaluation reserve on a class of asset basis, if the revalued amount option is used

An exercise is being undertaken to assess the respective advantages and disadvantages of the choices available on first time adoption. At this stage, the University has not determined the basis it will adopt.

#### (ii) Other Financial Assets (current and non-current investments)

AASB 132 Financial Instruments: Disclosure and Presentation

AASB 139 Financial Instruments: Recognition and Measurement

Each financial instrument held by UNSW must be classified at transition date into one of four categories and measured as follows:

- 1 Held for Trading Measured at fair value with movements recognised through the Statement of Financial Performance.
- 2 Held to Maturity Measured at amortised cost with movements recognised through the Statement of Financial Performance.
- 3 Loans and Receivables Measured at amortised cost with movements recognised through the Statement of Financial Performance.
- 4 Available for Sale Measured at fair value with movements recognised through the Investment Revaluation Reserve.

Initial indications are that the current investment Pool S (short to medium term) would be classified as held for trading (1 above), whereas Pool L would be classified as available for sale (4 above). This would not result in a change in accounting treatment.

Pool P investments (unlisted companies and intellectual property), which do not have a quoted market price in an active market, would be disclosed at cost and be subject to annual impairment tests identified within AABS136 Impairment of Assets.

#### (iii) Impairment

AASB136 Impairment of Assets

UNSW will be required to review the depreciation methods and residual values of assets on an annual basis. Impairment reviews will be required when an asset's recoverable value is considered to be impaired. As a minimum, the following factors must be considered;

- Has the asset's market value declined significantly more than expected?
- Have any significant technological, market, legal or economic changes taken place?
- Have market interest rates increased during the period and are they likely to affect the discount rate used in calculating the asset's value in use and therefore decrease the recoverable amount?
- Is there any evidence of obsolescence or physical damage?
- Have any significant changes occurred in the period, including the asset becoming idle, plans to discontinue use or restructure the operation, etc?

An impairment charge will be required where the recoverable amount is less than the asset's carrying value, with recoverable amount for UNSW being the higher of fair value less costs to sell and depreciated replacement cost.

#### (iv) Intangibles

AASB138 Intangible Assets

Research activity expenditure must be charged to the Statement of Financial Performance. Development expenditure must be capitalised if it meets certain criteria;

- Technical feasibility
- Intention to complete
- Ability to use / sell
- Future economic benefit
- Adequate technical and financial resources available
- Ability to measure expenditure on development project

Patents currently held by a controlled entity must be measured at cost, and cannot be revalued due to the absence of an active market. Patents must be amortised appropriately if management deem them to have a finite life. If they are deemed to have an infinite life, annual impairment tests are required.

Goodwill currently included within the financial statements of a controlled entity cannot continue to be amortised, but must be subject to annual impairment review. On transition, the controlled entity has the option to write off any goodwill held through accumulated funds, ie upon restatement of the opening IFRS balance sheet.

#### (v) Superannuation

AASB119 Employee Benefits

At present UNSW does not disclose any assets or liabilities of the Unisuper pension scheme due, it being a defined contribution scheme as opposed to a defined benefit scheme. As such, there can be no further call on the employers contributing, should the scheme be unable to meet its obligations.

Discussions are being held between DEST, the Auditor General and the AASB regarding the current multi-employer exemption for the Unisuper scheme. UNSW is monitoring the progress of these discussions to identify any changes required.

Superannuation discount rate

AASB119 will require superannuation post-employment liabilities to be discounted using either;

- a) the market yields on high quality corporate bonds, or
- b) where there is no deep market in such bonds, the market yields on government bonds.

This will result in a change in discounting methodology, as previously these liabilities were discounted using an estimated long-term rate of return on the Pooled Fund's asset allocation.

#### (vi) Subordinated Loan between UNSW and a controlled entity.

AASB132 Financial Instruments: Disclosure and Presentation AASB139 Financial Instruments: Recognition and Measurement

In July 1999, UNSW agreed to provide a \$10M interest free loan to support the activities of a controlled entity. UNSW has treated this as an investment eliminated on consolidation, and this treatment will not change under IFRS. The controlled entity has treated this loan as equity, also eliminated on consolidation. Due to the loan conditions detailing the requirement for the controlled entity to pay a return to UNSW upon reporting an audited profit, this will be classed as a liability in the financial statements of the controlled entity from 1 January 2005. The controlled entity then has the option of carrying the liability at amortised cost or fair value.

#### 31 Contingent assets and liabilities

#### **Contingent assets:**

The parent entity and consolidated entity had contingent assets at 31 December 2004 in respect of:

(i) Under commercialisation of research agreements between the participants in the former Cooperative Research Centre for Eye Research and Technology (CRCERT), UNSW is entitled to a percentage of continuing royalty payments including those deriving from sales by CIBA Vision Corporation (optical and opthalmic products and services). UNSW is not yet able to quantify the value of this entitlement.

#### **Contingent liabilities:**

The parent entity and consolidated entity had contingent liabilities at 31 December 2004 in respect of:

#### Claims

- (ii) The University has been advised of a potential issue by some members of the University of New South Wales Professorial Superannuation Scheme. The resolution of this matter is at an early stage and the financial impact, if any, has not been determined.
- (iii) Claims against the consolidated entity and the University in the normal course of activities. Based on advice received these claims are not expected to have a material effect.

#### Guarantees

- (iv) As at 31 December 2004 outstanding Staff Housing Scheme loan guarantees provided by the University pursuant to an agreement with the Commonwealth Bank of Australia total \$153,000 (\$188,000 in 2003).
- (v) AGSM has a bank guarantee with ANZ Banking Group in favour of Harina Company Limited for lease premises, \$694,000.
- (vi) The University has been granted a license under Division 5 of Part 7 of the Workers' Compensation Act, 1987. In accordance with the license the University has the following bank guarantees:
  - \$5,070,000 with ANZ Banking Group in favour of WorkCover New South Wales; and,
  - \$768,000 with ANZ Banking Group in favour of ACT WorkCover.

#### Other

(vii) There is a potential issue in regard to the amount of research income reported in prior years' Higher Education Research Data Collections to the Department of Education, Science and Training (DEST). This information has been used by DEST to calculate grants paid to the University under the following schemes: Research Quantum; Institutional Grants Scheme; and Research Training Scheme. The financial impact of this issue, if any, has not been determined, however it is not expected to exceed \$1.7M.

#### (b) Derivative financial instruments

The University of New South Wales and certain of its controlled entities are parties to derivative financial instruments in the normal course of business in order to hedge exposure to fluctuations in interest and foreign exchange rates and to trade.

#### (c) Credit risk exposure

The credit risk on financial assets of the consolidated entity which have been recognised on the statement of financial position, other than investments in shares, is generally the carrying amount, net of any provisions for doubtful debts.

The recognised financial assets of the consolidated entity include amounts receivable arising from unrealised gains on derivative financial instruments. For off-balance sheet financial instruments, including derivatives which are deliverable, credit risk also arises from the potential failure of counterparties to meet their obligations under the respective contracts at maturity. A material exposure arises from forward exchange contracts and the consolidated entity is exposed to loss in the event that counterparties fail to deliver the contracted amount.

#### (d) Interest rate risk exposure

The consolidated entity's exposure to interest rate risk as at 31 December 2004, and the effective weighted average interest rate by maturity periods is set out in the following table.

Exposures arise predominantly from assets and liabilities bearing variable interest rates as the consolidated entity intends to hold fixed rate assets and liabilities to maturity.
